**The U.S. Rotary Club & District Liability Insurance Program provides all U.S. Rotary clubs and districts and Rotaract clubs with commercial general liability insurance and directors & officers/employment practices liability insurance, subject to policy terms and conditions.**

You have received this email because you are an officer or officer-elect of your U.S. Rotary club.

This message is to advise that current U.S. Rotary Club & District Liability Insurance Program ("U.S. Club Program") policies will expire on 1 July 2024. New policies will be purchased to provide continuous coverage and Risk Management will strive to maintain coverage as broad as the current policies.

All U.S. Rotary clubs are assessed for the U.S. Club Program on the July Club Invoice and 2024-25 insurance assessment rates will be sent to you in June.

The insurance marketplace continues to improve. However, insurance companies are expected to raise rates due to the frequency of large, "nuclear" verdicts and climbing medical-related expenses arising out of third-party injuries, as well as inflation, which is moderating but nonetheless remains stubborn. We expect that this will affect the 2024-25 insurance assessment rates and the U.S. Club Program. A premium credit will be issued due to the U.S. Club Program's favorable history as far as losses, and this will in part mitigate increases in premium.

- copyright infringement claims and what you can do to prevent them (May)
- 2024-25 insurance assessment rates (June)
- 2024-25 insurance policies (July)
